Co-Chair Writes of Fellowship at WUP Events

Women United in Philanthropy continues to grow membership and the funds needed to award grant recipients. Since 2006 we have built our membership on women who have an interest in the local humanities, women with a passion for issues pertaining to women and children in our community, and women who want to educate themselves on and participate in philanthropic giving. Our members gain invaluable knowledge through other's experiences in the world of philanthropy while enjoying the fellowship of each other and guests at our WUP events.

Five years ago, *Women United in Philanthropy* donor members contributed \$15,000 to the collective fund. The recipient, the Jefferson Area Child Health Investment Partnership (CHIP) was able to purchase a van used to transport families across the community to a variety of medical appointments. This past year, our largest grant yet of \$40,000 was awarded to the Women's Initiative. This year, through the continued support and generous donations of our members, two grants will be awarded.

Our Founding Members can be proud of the growth in membership and contributions we have enjoyed over a relatively short amount of time. One of their original goals was to award a local non profit organization a grant that would make a significant difference for the recipient's impact on their clients and this community. By awarding

WUP February Panelists: “Philanthropy is Personal”

Women United in Philanthropy hosted the panel discussion “Philanthropy is Personal: Local Women Share Their Stories” on February 15, 2011 at the Omni Charlottesville Hotel. The panelists were Founding WUP Member Margery Daniel, Ph.D., LCSW; Peggy Echols, Vice President – Operations, State Farm Insurance; and Kate Zirkle, Independent Non-Profit Organization Management Professional.

We Join. We Learn. We Give. The posters behind the speakers’ table were a constant reminder of the mission of WUP. Steering Committee Co-Chair, Robin Amato, introduced the panel.

Marjorie led the discussion. “Modern day giving includes giving of time, expertise, and gifts.” She suggested finding your passion and doing your homework; researching the need and the program trying to fill that need. She related the story of the “butterfly effect.” The theory is that the movement of butterfly wings can have significant impact on wind current. “WUP works that way. Through WUP and our collaborative giving we make a significant difference.”

Peggy gets personal enjoyment out of giving. She looks forward to getting her United Way pledge card every year. It is a point of pride working at State Farm to be involved in the community through volunteering and giving. She encourages giving in any way you can whether it’s time or money. “Whatever you can do as an individual can make a difference.”

Kate’s passion is the Boys and Girls Club. She likes to spend time at the Club getting to know the boys and girls. You can’t always write a big check, but you “can give with time and help with fundraising”. Kate also stressed you should expect measured results for your donations.

Jennifer Ackerman to Speak at Fall Luncheon

Join us October 4, 2011, for *Women United in Philanthropy’s* annual Human Services Grant Award Luncheon at Farmington Country Club. Jennifer Ackerman will be our guest speaker.

An award-winning writer whose work has appeared in *The New York Times Magazine*, *Scientific American*, *National Geographic*, and *Nature Conservancy*, Jennifer Ackerman has been writing about science, nature, and health for the past two decades. Her work aims to explain and interpret science and health for a lay audience and to explore the riddle of humanity’s place in the natural world, blending scientific knowledge with imaginative vision.

Ms. Ackerman’s most recent books are *The Social Network Diet: Change Yourself, Change the World* (FastPencil, 2011), written with Dr. Miriam Nelson, and *Ah-Choo! The Uncommon Life of Your Common Cold* (Twelve, 2010).

From 1998-2002, Ackerman served on the Editorial Board of the University of Virginia Press. She has lectured at Harvard University, the Massachusetts Institute of Technology, the University of Virginia and its Medical Center, the American Association of University Women, and for numerous other groups and organizations. We are very pleased to welcome her as our keynote speaker.


